You may unsubscribe at any time either directly from the newsletter or from the FTMarkets Home Page.

WHAT INFORMATION ABOUT YOU DO WE COLLECT?

To receive our newsletters on a routine basis and When you visit our Website, you may provide us with two types of information: (1) personally identifiable information that you knowingly choose to disclose, which is collected on an individual basis, and (2) general user information that does not contain personally identifiable information, which is collected on an aggregate basis as you subscribe for our newsletter or when you browse our Website. In some cases, if you choose not to provide us with requested information, you may not be able to access all of our Website's and newsletters content or services.

Personally Identifiable Information You Choose to Provide.

We may ask for certain personal information from you for the purpose of providing to you content and/or services that you request. For example, if you indicate an interest in receiving press releases about FT-MARKETS, you are asked to submit your name and e-mail address, which we retain on file, so that we may send you the information that you requested. Non-Personally Identifiable Information collected by us.

Cookies/ Web server logs: Similar to other commercial Websites, our Website utilizes standard technology called "cookies" and Web server logs to collect information about how our Website is used. Cookies are a feature of Web browser software that allows Web servers to recognize the computer used to access a Website. Cookies are small pieces of data that are stored by a user's Web browser on the user's hard drive. Information gathered through cookies and Web server logs may include the date and time of visits, the pages viewed, time spent at our Website, and the Websites visited just before and just after our Website. This information is

collected on an aggregate basis. None of this information is associated with you as an individual. You can, of course, disable cookies on your computer by indicating this in the preferences or options menus in your browser. However, it is possible that some parts of our Website will not operate correctly if you disable cookies. You should consult with your browser's provider/manufacture if you have any questions regarding disabling cookies.

User Information

We collect the following user information: unique identifiers, the user's name, company name, department, designation, contact address, mobile number and e-mail address. At the user's option, we may also collect preference data.

The data may be used by us for the following purposes:

- Contacting the user for various organizational purposes
- Website and system administration
- Research and development
- Anonymous user analysis
- Anonymous user profiling and decision making
- Contacting visitors for the marketing of services or products (the user may opt out of this usage)
- To review whether users qualify for membership

We use your personally identifiable information to provide you with the information or content that you have requested, and, in some cases, to contact you about our programs, products, features or services.
